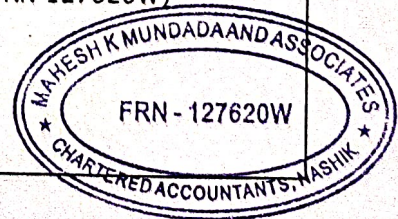
SIGNIFICANT ACCOUNTING POLICIES :


- 1 The accounts are prepared in accordance with the generally accepted accounting principles. The significant accounting policies to the extent applicable to the trust are as under:

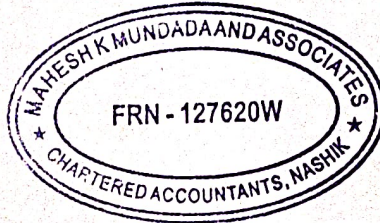


